

Student/Parent Conduct Agreement



I, _____, as a member/guest of the Laurel Church of Christ Youth Group (LYF), agree to behave in a manner reflective of the attitude of Jesus Christ while on this trip. I understand that my behavior not only affects me but also the youth group with which I am attending, the church that youth group is a part of, and the kingdom of God. I will follow the rules set by Jonathan Thomas and approved by the elders of the Laurel Church of Christ, any rules set by Kings Island staff and businesses between Knoxville and Mason, OH, AND the rules of common sense. I understand that breaking these rules may result in a call to my parents, and I may be sent home without a refund. LYF's rules are as follows:

- 1) I will remain with the LYF group at all times.
- 2) I will listen to **all** chaperones at all times and do as they say as long as it is within reason.
- 3) I will meet with the youth group at the appointed times and will not be late.
- 4) I will wear appropriate clothing while on this trip. I agree that clothing not covering my body parts, marked with offensive images, or other inappropriate clothing as defined in our pre-trip meeting, is not permitted. We are requiring all females to wear one-piece suits or tankinis if they choose to go to the waterpark.
- 5) I will make sure my electronic devices do not become a distraction or a source of impropriety. I understand that these devices may be taken away and returned to me at the end of the trip if issues arise.
- 6) I will not engage in any sexual activity during this trip.
- 7) I will not bring or partake of any illegal/unauthorized drugs, alcohol, tobacco, or other illegal substances on this trip. Any prescription or over-the-counter medications I bring will be given to my chaperone before we leave.
- 8) I will not bring or purchase any weapons, including air soft guns, blow darts, and/or knives.
- 9) I understand that anything I bring, including money and valuables, is my responsibility. I will keep up with my possessions at all times.
- 10) I understand that asking a chaperone to take me home early is not an option.
- 11) I will refrain from any other activities that are generally stupid throughout this trip.
